1. Geophysical surveys around selected turbines at Moray East Wind Farm

Please be advised that Moray Offshore Windfarm (East) Limited (Moray East) are planning to undertake SSS and MBES surveys around several Wind Turbine Generators (WTG)locations (Table 1 and Figure 1). The geophysical survey is covering an area of approximately 300m x 300m centred on the WTG (See example in Figure 2). The Interconnector Subsea cables between OSP1 and OSP2 and OSP2 and OSP3 will also be surveyed, A number of Inter Array Cables show below are to be surveyed . The survey vessel to be used is the Geo Surveyor XI, detailed below. Activities are expected to take place between 10/10/2024 and 25/11/2024 weather dependant

2. General Safety advice

Please be aware that, during the survey activities, by virtue of its mode of operation the vessel (Ondine Jule) will be Restricted in her Ability to Manoeuvre (RAM) as defined under COLREGs (International Regulations for Preventing Collisions at Sea 1972, Rule 3). Masters of vessels are therefore requested to maintain their vessels and gears at a minimum safe passing distance from the vessel of 500 metres when it is undertaking work and showing the appropriate shapes and lights in accordance with COLREGs Rule 27. In order to not compromise the safety of the Survey Vessel, their crew, and their ability to undertake its contracted works, fishermen who have static fishing gears deployed within 500 m from the WTG where survey activities are planned (see Table 1 and Figure 1) are requested to provide the coordinates of such deployed gears in DMS and details of whether the surface markers used are visible at all states of visibility to Alex Winrow-Griffin (Brown & May Marine) using the contact information below (Section 58 of the Merchant Shipping Act 1995). Fishermen who have static gears deployed beyond 12 nm are reminded that static gear must be marked in accordance with Commission Implementing Regulation (EU) No. 404/2011 (https://www.gov.uk/guidance/marking-of-fishing-gear-retrieval-and-notification-of-lostgear#marking-of-fishing-gear).
