**1. Meteorological Unlit Mast Corrective Maintenance**

Please be advised that Moray Offshore Windfarm (East) Limited (Moray East) Meteorological Mast is currently unlit.




Figure 2 – Meteorological Mast location map

On Friday the 11<sup>th</sup> of October a rope access team will mobilise from Lossiemouth to gain access and undertake corrective maintenance to the Meteorological Mast (Figures 1 and 2, location in Table 1)

Corrective maintenance should take circa 1 day to complete and the Vessel Coral Wind will be utilised for said works.

Confirmation of completion of corrective maintenance will be provided via closure of NTM 8460001-PC0010-MWE-NTM-009 (26-08-2019), mentioned in the Weekly notice of operation and cancelling of WZ marine safety broadcasts.

Until such time during hours of darkness / low visibility the Guard Vessel Ability will remain in the vicinity of the Mast and alert any transiting traffic within the CDM area of the Hazard. Vessel details are provided below.
