1. Scour Protection Operations.


Please be advised that Moray Offshore Windfarm (East) Limited (Moray East) are planning to commence scour protection operations in preparation for forthcoming Jacket installation work scope at five locations within the bounds of Moray East Offshore Windfarm circa 30th April 2020. The locations of each of the five assets where scour protection will be installed is shown in Figure 2 and Table 1 below.


The work will comprise of rock dumping from the Flintstone via fall pipe, area covered on each of the five asset locations is shown in Figure 1 below.
