1. Jacket Installation




Figure 1. Moray East Site 1 (Offshore Windfarm Area)

Please be advised that Moray Offshore Windfarm (East) Limited (Moray East) are planning to commence Jacket installation (subject to receipt of required regulatory approvals) on all of the pre piled areas (shown in figure 1) using Seajacks Scylla circa 27/06/2020 until further notice. Once the Jackets have been installed Boa Sub C will be utilised for grouting operations on the newly installed jackets as well as the continuation of the soil plug removal. Further updates will be




Figure 3. Photo of Jackets to be installed.
